Application Requirements:

- 1) **COMPLETE ALL SECTIONS** of the application. Preferably TYPE or use PEN --**NO PENCIL. DO NOT JUST ATTACH YOUR RESUME**
- 2) Applicant must provide **ONE** teacher recommendation and **ONE** non-CISD/ non-relative recommendation. These recommendations need to be submitted with your application in sealed envelopes. **Please provide these forms and envelopes to the person recommending you well in advance to allow for time to complete and return to you prior to the deadline. Teachers have a maximum of 6 recommendations that they can do, so ask early!**
- 3) All applications will be scored by the same rubric. It is very important that you take time to answer these questions thoroughly and accurately. **An inaccurate or incomplete application will most likely eliminate your chances for a scholarship. You can include additional pages where needed.**
- 4) Application packets are due to your counselor by **March 1, 2021**. **No late applications will be accepted.**
